Military Scholarship Program **Student Application**

PURPOSE OF THE PROGRAM:

The intent of the scholarship program is to directly support individuals who have served in the armed forces of the U.S. who specifically self-finance their education. This means to individuals paying their tuition through personal or family loans, VA benefits, GI Bill or other personal scholarships qualify to submit their application.

Companies who pay the tuition for their employees cannot benefit from this individual focused scholarship program. Companies may not realize the reduction in cost afforded their employees should the scholarship exist. Any savings must be passed on to the individual employee directly.

Individuals who are employed by companies who do NOT have an existing corporate agreement with IIEI/DSU, may qualify for the military scholarship program. Speak to an advisor to see if you may qualify.

ELIGIBILITY:

The following eligibility requirements must be met for a student to receive the military scholarship:

- a) Student is Active / Former Military or a Dependent of Active / Former Military: Student must be able to submit the following documentation to be eligible for this scholarship:
 1. Form: DD-214
 2. LES Form: Leave and Earnings Statement (Must include discharge details!)
- b) Honorable Discharge: The student must have been honorably discharged from their service branch.
- c) Method of Payment: The student must self-finance their education, and any payments received must be made by the student or a member of the student's family. Payments made by the student's employer, the VA, or other third-parties are ineligible for this scholarship. Students must utilize one of the following methods of payment:
 1. Credit Card Charge (By Phone or Online at www.dunlap-stone.edu)
 2. Check by Mail (Personal Check, Cashier's Check Only – No company checks)
 3. Deferral Promissory Note
- d) No Other Scholarships or Discounts Applied: The student may not apply other scholarships or discounts while utilizing the Military Scholarship. This includes corporate memberships.
- e) Completion of the Military Scholarship Program Student Application: The student must complete the application and submit the required documentation (see Eligibility Requirement #1). The application page immediately follows on next page.
